The licensee named above is authorised to sell liquor at the licensed premises described above, in accordance with the Liquor Control Act 1988 ("the Act"). The licensee must comply with all requirements and conditions imposed by the Act, any conditions or authorisations published by notice under s 31 of the Act, and any conditions or requirements set out below. The licence continues in force until surrendered or cancelled under the Act.

EXTENDED TRADING PERMITS

TRADING HOURS AND CONDITIONS

TRADING HOURS - HOTEL LICENCE

Unless otherwise varied by a condition on this licence, the permitted trading hours in accordance with s 98 of the Act are as follows:-

- (a) on a day other than a Sunday - from 6 a.m. to midnight;
- (b) on a Sunday - from 10 a.m. to 10 p.m.;
- (c) on a Sunday that is New Year's Eve - from 10 p.m. to 12 midnight;
- (d) on New Year's Day - from immediately after 12 midnight on New Year's Eve to 2 a.m.;
- (e) on Good Friday or Christmas Day - from 12 noon to 10 p.m., but only for liquor sold ancillary to a meal supplied by the licensee;
- (f) on ANZAC Day - from 12 noon to 12 midnight.

The permitted hours under a hotel licence for the sale of liquor to a lodger are unrestricted.

TRADING CONDITIONS

1. The sale of packaged takeaway liquor is to be restricted to between 10 a.m. and 9 p.m daily;
2. Exterior lighting is to be provided on both the NAMES OF STREETS HERE Street frontages of the licensed premises
3. Strict codes of dress and hygiene are to be applied and clearly advertised

4. The licensee shall ensure that the cameras as approved by the Director in the public areas of the premises and at the public entrances to the premises (i.e. entrances to the premises, bar areas and entertainment areas (pool room/dance areas) shall not be removed without the approval of the Director.

A video surveillance system must be in place and operational. The system must comply with the minimum requirements identified in the "Security at Licensed Premises" Policy or with requirements otherwise approved by this authority. In accordance with the Policy, it is expected that this system will provide and record continuous images of the entrances to the premises from 8 p.m. (or the time of opening the premises if after 8 p.m.), until 1 hour after trading ceases.

Images recorded via the video surveillance system must be retained for twenty-eight (28) days, and must be made available for viewing or removal by the Police or other persons authorised by the Director of Liquor Licensing.

COMPLIANCE WITH SECURITY AT LICENSED PREMISES POLICY

The licensee (LICENSES NAME HERE) has advised that a compliant video surveillance system has been installed at these premises and is fully operational, and that the required security staff and crowd controllers are employed.

ENTERTAINMENT CONDITION

(a) A person resorting to, or on the premises, including the licensee or manager, or an employee or agent of the licensee or manager, shall not:

- (i) be immodestly or indecently dressed on the licensed premises, and/or
- (ii) take part in, undertake or perform any activity or entertainment on the licensed premises in a lewd or indecent manner.

(b) The licensee or manager, or an employee or agent of the licensee or manager, is prohibited from:

- (i) exhibiting or showing, or causing, suffering or permitting to be exhibited or shown, on the licensed premises any classified "R 18+", "X 18+" or "RC" classified publication, film or computer game or extract therefrom; or
- (ii) causing, suffering or permitting any person employed, engaged or otherwise contracted to undertake any activity or perform any entertainment on the licensed premises to be immodestly or indecently dressed on the licensed premises; or
- (iii) causing, suffering or permitting any person to take part in, undertake or perform any activity or entertainment on the licensed premises in a lewd or indecent manner.

(c) In this condition "licensed premises" includes any premises, place or area:

- (i) which is appurtenant to the licensed premises; or
- (ii) in respect of which an extended trading permit granted to the licensee is for the time being in force, but does not include any part of the premises which is reserved for the private use of the licensee, manager or employees of the licensee and to which the public does not have access.

COMPLIANCE WITH HARM MINIMISATION POLICY

The licensee has lodged a copy of the House Management Policy, Code of Conduct and Management Plan developed for these premises in accordance with the Harm Minimisation Policy. These documents must be retained on the licensed premises and produced to any Authorised Officer if required.

This licence takes effect from **19 August 2020**.
