Step 1 Apply for pre-approval

- Businesses must first register to confirm their eligibility.
- Only one rebate is available per eligible business/alfresco area.

Step 2 Claim for eligible expenses

- Businesses that have successfully registered can claim their rebate.
- Claims must be made by 17 June 2022.
- The rebate will be provided as a one-off payment.



Have an active Australian Business Number (ABN)



Have incurred eligible expenses for establishing, expanding or improving an outdoor dining area



Be located in WA



Have a permit or approval to operate an outdoor dining area from the relevant local government valid for at least six months from 1 March 2022 and/or consent of the landowner



Be a food and beverage business, such as 'pub, tavern, bar or hotel' or 'restaurant and café'.



Have a minimum revenue of \$50,000 per annum (excluding GST) and an Australia-wide payroll cap of less than \$4 million.

Fee-free permits for extended alfresco trading

For a **brand new** ETP alfresco area, licensees are invited to complete the Extended Trading Permit Alfresco Area COVID-19 application and email it, together with the plan for the requested area and relevant approvals to liquorc19@dlgsc.wa.gov.au

To extend an **existing** alfresco area, licensees are invited to complete the Form 11 – Notice of application to add, vary or cancel condition of licence or permit application and email it, together with the plan for the revised area and relevant approvals to liquorc19@dlgsc.wa.gov.au



- Booking spaces






