We are very aware of the danger of fire and we are required to maintain cleared area of 20metres circle around our house and other buildings.

We have a good Volunteer Fire Brigade that keeps us informed about preparing for the Bushfire Season etc.,

We have fresh air hopefully that will remain.

Quiet roads although many cars in the area.

We don't have street lights.

We can't rely on Public Transport as it is non existent.

I don't know of anyone who has a taxi in the area.

We do have 3 community businesses that supply petrol.

Many rely on the water that drops from the sky and most use water at least twice.

You won't find any hoses used indiscriminately and water running down the road.

We pay the City of Swan rather high Waste and Recycling Services charge and don't have any roadside collection of unwanted goods such as fridges, washing machines. or greenwaste not even once a year.

In my area we don't have a Doctor as yet, nor major shops.

Closest Police are approximately 20kms away.

Some of us drive 120kms or more to work and back daily.

We put up with not having access to a Mobile Phone service, not even Telstra for me.

It is important to retain a Home Phone Landline as when the power goes out which has been quite frequent over the years and that means one should always have a tankful of petrol in the car. No phone, no computer, no lights, no water to the house because rely on electric pump to send it to the house. That also means no showers or toilet flushing.

It isn't primitive, living rural is challenging and hard work tending to the fences, pipes and animals, and the never ending raking picking and packing into chaff bags for the social interaction with the people at the Red Hill Site where I take all my greenwaste. This is a far cry from living in the houses on the flats of the North, South and West suburbs.

Cannot compare. So far haven't got anything to complain about and making the change to the country from centre of the city living, don't want to ever go back there to live.

In considering the question of UV or GRV take into account all of the above things that we don't have .

It has been called Special Area for several years
