

Financial Assistance Grants

Financial Assistance Grants: 2023-24 Grant Allocations

The *Local Government (Financial Assistance) Act 1995* (Cth), provides for an annual adjustment to the national funding pool for the general purpose component of the Financial Assistance Grants (FA Grants). FA Grants are calculated by indexing the previous year's funding pool by Consumer Price Index (CPI) and population growth. The annual increase to the national funding pool for local road grants is calculated by indexing the previous year's funding pool by CPI. The legislation also provides for the Commonwealth Treasurer to vary this adjustment in special circumstances.

In 2023-24, WA received an increase to its general purpose grant and to the local roads allocation (including adjustments for underpayment in the previous year).

The Western Australian share of Commonwealth funding for 2023-24 is \$377,625,444 being 12.16 per cent of the national allocation of \$3,106,445,787. WA's share consisted of \$231,362,524 for the general purpose component and \$146,262,920 for the local roads component.




Figure 1. National Distribution of Financial Assistance Grants 2023-24



The final amount of FA Grants to be distributed for 2023-24 is \$16,050,137 million higher, at \$393,675,581, to reflect a positive adjustment to the 2022-23 State allocation. This is a result of the Commonwealth rectifying an underpayment of grants made to the State in 2022-23 due to adjustments to the estimated State population and inflation used in the previous year's grant calculation. This year's adjustment consists of an additional \$9,736,675 for general purpose grants and \$6,313,462 for local roads.

The Commission calculates the "Equalisation Need" for general purpose grant funding for all local governments, based on calculations of the revenue-collecting capacity of each local government, and magnitude of expenditure each local government would be required to incur to deliver a consistent general standard of services across the State.

The total general purpose grant funding received by the State is commonly less than the total equalisation need calculated by the Commission. For 2023-24, the total statewide general purpose grant funding was approximately 64 per cent of the calculated statewide Equalisation Need.

In 2023-24, the general purpose grant funding received by the State allowed for 64 per cent of calculated grant need to be paid to local governments. If a local government was receiving greater than this, they received a reduction in their grant. Reductions have been phased in over the past 7 years to provide some level of stability in grant funding. If a local government was receiving less than 64 per cent, the grant increase provided was as much as the available funding pool would allow.

As part of the process of transitioning all local governments to a uniform scale back figure, being 64 per cent of calculated grant need for the 2023-24 grant determinations, the Commission has been able to ensure that all local governments receive the same percentage of their calculated grant need this year and in future years.

*This table does not include the 32 minimum grant local governments. Minimum grant local governments are deemed to be self-sufficient and do not need the financial assistance grant funding when compared to other WA local governments.

Local governments that were deemed to be a minimum grant local government, had their grant calculated on a per capita basis in accordance with the minimum grant principle under the *Local Government (Financial Assistance) Act 1995* (Cth). Further detail on these calculations is provided later.

Advance Payment of 2023-24 Financial Assistance Grants

The Commonwealth Government advised in June 2023 that it would make an advance payment of the 2023-24 FA Grants in the 2022-23 financial year. The advance payments were calculated by the Commonwealth Department of Infrastructure, Transport, Regional Development, Communications and the Arts and distributed to local governments via the WA Department of Treasury.

This year, the advance payment was significantly higher than the previous advance payments of 50 or 75 per cent per of WA's estimated 2023-24 FA Grant entitlement, with the State Government receiving 100 per cent of the estimated FA Grant allocation upfront. The advance consisted of \$230,921,687 in general purpose grants and \$135,762,877 in local road grants.

The Commonwealth has noted the impact of providing a bring forward payment at 100 per cent, with local governments needing to ensure sufficient funds remain for 2023-24 with much smaller incoming quarterly payments due to the remainder of the 2023-24 grants entitlements totalling \$16,769,018 for the State.

The allocation to local governments from the Commonwealth for the advance payments is based on grant recommendations from the prior year (2022-23) with indexation in line with the growth to the grant allocation to WA. However, as detailed in this annual report, the WA Grants Commission methodology allocates funding not purely based on indexation of the grant pool but based on a variety of factors to ensure equitable distribution that is appropriate for the State.

The difference in the two allocation methods has resulted in some local governments being overpaid in 2023-24 funding allocation, and some being underpaid. This process will be reversed in 2024-25 to ensure the over and under payments reconcile with actual entitlements, bringing the net effect to zero (\$0) over the two years of grant funding.

The Commission will continue to advocate for advance payments that do not impact on the financial sustainability of local governments and for normalisation and consistency in advance distribution.

Advance payments were made to local governments on 30 June 2023.

Methodology used for 2023-24

Each year the Commission implements updated data as provided by local governments as well as undertaking reviews of the revenue standards, expenditure standards and cost adjustors.

These reviews are informed by research and through discussions held on the visiting programs. A copy of the calculations and methodology used can be found on the Commission's website.

In 2023-24, the Commission determined the following cost adjustors to be of the greatest importance to local government.




Figure 3. Cost adjustor allocation for Financial Assistance Grants 2023-24

Refinements and Review of the Methodology for 2023-24

The Commission calculates the allocation of the general purpose grants each year in accordance with the Commonwealth National Principles.

For 2023-24, 87 per cent of expenditure calculations were distributed using a per capita or per property allocation with the remaining 14 per cent allocated by the cost adjustors, to recognise costs which are out of a local governments control.

While the Commission's methodology review is still underway, no major refinements were implemented for the 2023-24 grant determinations. However, there were some minor changes that are noted below.

Off-Road Drainage

Drainage infrastructure and costs are not collected annually, it is collected every three to five years. Some local governments provided data in 2019, some in 2022, some in both and some not at all. To ensure an equitable distribution of FA grants the Commission encourages all local governments to provide accurate costs when requested. As a result, there was a significant increase to the assessed allowances for 2022-23. The total off road drainage allowance for 2023-24 is \$14.79 million, which is a 5% increase from 2022-23 which was \$14.1 million.

The major factor in the increase to assessed allowances was revised drainage data particularly from Armadale, Canning, Capel, Cockburn, Gosnells, Joondalup and Wanneroo accounting for 77% of the \$702,941 increase in allowances.

Transport Standard

The Commonwealth's 2020-21 Local Roads and Community Infrastructure Program (LRCIP) funding stream was allocated to local governments largely based on asset preservation needs but were not required to be spent on roads. Based on the WALGA Road Assets and Expenditure Report, 17% of the \$190.6 million provided in Phases 1 and 2 was spent on roads. As this expenditure was not necessarily for asset preservation exclusively, it is proposed to take 71% of this expenditure (\$22m) into account, as this represents the proportion of general local government expenditure on roads that focuses on asset preservation. The effect of this inclusion of 12% of the LRCIP is to increase the total preservation grants netted out from the required transport expenditure from \$257.2m to \$280m. This had the effect of reducing the transport standard expenditure calculated for local governments and resulted in reductions to local government equalisations in many circumstances.

Cost adjustors

Each year the Commission updates the indicator data used in the cost adjustors. This ensures that the calculations are accurate and equitable for the state. For certain cost adjustors, updates to indicator data results in the changes to state averages, they are listed below:

Medical Facilities

The Commission requested that the doctor and nurse practitioner expenditure categories that are recognised through the medical cost adjustor be more specific to recognising the direct cost to local governments. As a result, the final expenditure categories to be recognised are now; doctor (salary/retainer), car, housing, doctors surgery (rent forgone), communication expenses, and other costs.

However, the removal of several previously recognised categories resulted in the allocation to the medical cost adjustor being far more than needed and was recognising up to 120% of local government expenditure. Therefore, the Commission agreed that this be manually adjusted so the percentage of a local governments expenditure be recognised at 82% and capped at \$85,000. Due to the variable nature of medical costs, the Medical Cost adjustor will no longer be indexed in line with the other cost adjustors. The Commission will review this percentage each year. In 2022-23, there were 14 local governments who received the maximum allowance of \$85,000.

Growth Data

The Commission updated the historical growth data range from 2016 to 2020 to 2017 to 2021. Future growth data is updated to 2026 to 2031. The updated historical data means that a range of local governments that previously received an allocation for Growth, would not be eligible based on the new criteria within the calculation.

Special Needs

The Commission provided Special Needs funding to two local governments in 2022-23. The Shire of Gingin for the Lancelin Off-Road Vehicle Area and the financial impact it has on the Shire and the Shire of Murchison for the financial impact of being off the power grid. The special needs cost adjustor remains at \$80,000.

Revenue Standards

Revenue standards are a mathematical formulae used to assess the revenue earning capacity of each local government.

The Commission calculates the following revenue standards:

- Residential/Commercial/Industrial Rates
- Agricultural Rates
- Pastoral Rates
- Mining Rates
- Investment Income

Most revenue standards use regression analysis as the basis to inform the decision. Regression analysis is a tool for analysing relationships between variables.

Residential Commercial Industrial

The Commission approved the recommendation to use the RCI new regression formula of 37.56% on number of properties and 62.44% on valuations.

The final formula is \$708.88 x number of properties + 0.048 x valuations.

Pastoral Rates

The Commission approved the recommendation to adopt the regression formula for the Pastoral Standard of 19% on properties 33% on valuations and 48% on area.

The final formula was 0.02804 x valuations + 0.01261 x area (Ha)

Mining Rates

The Commission approved the recommendation to adopt the Mining Standard formula of 0% on Area, 84% on valuation and 16% on number of properties. An adjusted formula was used for Wanneroo, Port Hedland, Ashburton and Kwinana to reflect their significantly higher rating capacity.

Formula for all LGs excluding Wanneroo, Port Hedland, Ashburton and Kwinana. 0 x area + 0.1470 x valuations + 490.49 x number of properties

> Formula for Wanneroo, Port Hedland, Ashburton and Kwinana. 0 x area + 0.2651 x valuations + 909.58 x number of properties

Due to the Shire of Ashburton not returning the 2022-23 information return, the formula relating to area was reduced to 0%, as this is only applicable to this Shire.

Agricultural

The Commission approved the recommendation to adopt the Agricultural Standard model weightings of 24% on number of properties, 39% on valuations, and 37% on area.

The final formula was \$873.58 x number of properties + 0.0026 x valuations + 3.85 x area.

Investment

The Commission approved the recommendation to adopt the updated Investment Revenue formula.

The final formula was Population x \$7.40.

Expenditure Standards

Recreation and Culture

The Commission approved the recommendation to adopt the updated Recreation and Culture Standard formula.

The final formula was \$299.52 x LG Population + Cost Adjustors.

Governance

The Commission approved the recommendation to adopt the updated Governance Standard formula.

The final formula was \$184.62 x Number of Rateable Assessments + cost adjustors.

Community Amenities

The Commission approved the recommendation to adopt the updated Community Amenities Standard formula.

The final formula was \$144.71 x Number of Rateable Assessments + Cost Adjustors.

Education, Health and Welfare

The Commission approved the recommendation to adopt the updated Education, Health and Welfare Standard formula.

The final formula was \$47.51 x LG Population + Cost Adjustors.

Law, Order and Public Safety

The Commission approved the recommendation to adopt the Law, Order and Public Safety Standard formula.

The final formula was \$73.60 x Number of Rateable Assessments + Cost Adjustors.

Transport

The Transport Standard figures used are those approved as presented to the Commission at the meeting on 3 August 2023.

The final formula for was Factored Back Transport Needs – Road Preservation Grants.

Reviews proposed for 2023-24

The Commission has continued its review of all components of the methodology in 2023-24. The Commission's next focus is on the review and composition of the five revenue standards. The last major review was completed for the 2012-13 grant calculations.

Local Government Submissions

The Commission received five formal submissions in 2022-23, from the Shires of Derby West Kimberley, Ngaanyatjarraku, Christmas Island, Murchison and the City of Bunbury.

Any decision made on the following submissions will be implemented and reflected in future grant determinations.

The Commission welcomes feedback from local governments at any time either through a formal submission or comments on the methodology to grants.commission@dlgsc.wa.gov.au.

Minimum Grant Local Governments

In 2023-24, 32 local governments (of the 137 total in WA) received the minimum grant entitlement which equated to \$24.90 per capita. This was an increase from 2022-23 when local governments received \$22.94 per capita.

Collectively, the local governments receiving the minimum grant accounted for \$52.9m (23 per cent) of the total general purpose funding pool while comprising 76 per cent of the State's population.

The Commission has a policy whereby, for a five-year period, it will provide any amalgamating local governments the higher of the amalgamating local governments' individual general purpose grants, combined and pegged at pre-amalgamation levels, or the new equalisation of the new entity. Currently there are no WA local governments operating within the amalgamation maintenance period.

Grants Determination Process

The Commission maintains its administrative processes to provide for timely notification of grants to local governments. The Commission met to confirm the Final Grant Schedule of FA Grants for 2023-24 on 3 August 2023. The WA Minister for Local Government approved the Commission's final allocation of FA Grants on 8 August 2023. The Commonwealth Minister for Local Government approved the final grant allocations on 10 August 2023.

Publication of Grant Calculations

The Schedule of Payments contains all the information relating to each local government's FA Grants, including general purpose grants, road grants and special project grants where applicable. The Balanced Budget details the calculation of each local governments general purpose grant. Both documents are made available to local governments on the DLGSC's web page.

Public and Special Hearings

In accordance with the *Local Government (Financial Assistance) Act 1995* (Cth), the Commission undertakes public hearings with local governments. The hearings consist of a formal presentation about the operations of the Commission. At the hearing, local governments are given the opportunity to present submissions to the Commission on their individual grant determination and any issues relevant to the grant determination process.

The hearings facilitate discussion between councillors, staff, members of the public and the Commission. Due to the large number of local governments in WA, the Commission aims to hold public hearings with each one at least once every five years. Through these hearings, the Commission can gain a greater understanding of the issues affecting local governments and their capacity to provide services and facilities to their communities

to their communities.

The Commission tries to ensure that all local governments and other interested parties have the opportunity to understand the grant determination process and to present their views or suggestions on any aspect of the process.



In 2022-23, the Commission conducted public hearings at the following 12 local governments:

In addition to the public hearings, local governments can request a special hearing with the Commission, at any time. This provides any local government with an opportunity to present a submission on the grant determination process to address issues of an urgent nature.

Issues raised at public hearings

As part of the hearings, the Commission provides an opportunity for local governments to raise methodology related issues as well as more general concerns that go beyond the scope of the Commission, to offer guidance and to raise awareness of issues affecting other local governments.



General Issues

Over the past 12 months, local governments raised the following general issues and matters of interest with the Commission during public hearings:

- Housing availability and costs
- Staff attraction and retention
- Road conditions and maintenance
- Tourist impacts on local infrastructure
- Climate/Heavy rainfall
- Fuel/Freight costs
- Fire mitigation costs; and
- Inaccurate Aboriginal Census counts.

Submissions

Each year, local governments are given the opportunity to highlight disadvantages they face in the provision of local government services through submissions to the Commission. In 2022-23 there was one Local Roads submission made to the Commission from the Shire of Christmas Island.

Grants to Indian Ocean Territories

The Commission provides advice to the Indian Ocean Territories Administration on the level of FA Grants to be provided to the Shire of Christmas Island and the Shire of Cocos (Keeling) Islands. The funding for both shires is assessed separately to the allocation of FA Grants for WA's 137 local governments. Grant funding is allocated directly by the Commonwealth and does not come out of the State funding pool.

The Commission mostly assesses the funding requirements of these two shires in accordance with the same methodology applied to Western Australian local governments. Some specific cost adjustors are applied to recognise the unique situation of the Indian Ocean Territories. The local road funding grant is assessed in accordance with the Asset Preservation Model (APM).

Local Road Funding

The Commission calculates the road grant allocations using the APM which has been in place since 1992. The APM recognises the maintenance costs based on existing road assets of each local government and regional differences in the cost of maintenance.

Local road inventory data is a critical input to the APM and local governments are encouraged to maintain comprehensive and up to date inventory data.



For 2023-24, WA received \$146,262,920 of the total national local road funding pool of \$954,764,375 representing 15.29 per cent of the national total.

Ninety-three per cent of the Commonwealth funds for road grants are distributed to local governments in WA according to the APM.

Under the current methodology, seven per cent of the funds are allocated for special projects; one-third of this is for roads servicing Aboriginal communities and two-thirds is for bridges.

Main Roads Western Australia (MRWA) contributes one third of the cost of projects funded under this program.

Distribution of the Asset Preservation Model component

In 2023-24, \$136,040,921 will be distributed in accordance with road preservation needs determined by the Commission's APM. The model assesses the average annual costs of maintaining each local government's road network and has the facility to equalise road standards through the application of minimum standards. These standards help local governments that have not been able to develop their road systems to the same level as other more established local governments.

Special Projects: Roads Servicing Aboriginal Communities

The Aboriginal Access Roads Committee advises the Commission on procedures for determining the allocations of Commonwealth road funds for roads servicing remote Aboriginal communities and recommends the allocations that are made each year.

Membership of the committee is made up of representatives from each of the following organisations:

- Western Australian Local Government Grants Commission (Chair)
- Western Australian Local Government Association
- National Indigenous Australians Agency
- MRWA
- Department of the Premier and Cabinet
- Department of Communities
- Department of Planning, Lands and Heritage; and
- DLGSC.

The committee has established funding criteria based on factors including the number of Aboriginal people serviced by a road, the distance of a community from a sealed road, the condition of the road, the proportion of traffic servicing Aboriginal communities and the availability of alternative access. These criteria have provided a rational method of assessing priorities in developing a five-year program.

Special project funds have been allocated for improvements to Aboriginal access roads over many years, and it is pleasing to see continuing improvements in road standards.

Special Projects: Bridges

The Commission's policy for allocating funds for bridges recognises that there are many local government bridges that are in poor condition and that the maintenance and preservation of these bridges must be given a high priority.

The special project funds for bridges are only allocated to preservation projects, recognising that some of these projects may include some upgrading and that preservation includes replacement when the existing bridge has reached the end of its economic life.

MRWA contributes one third of the cost of all projects funded under the special projects program.

The Bridge Committee advises the Commission on priorities for allocating funds for bridges. Membership of the Committee is made up of representatives from the following organisations:

- MRWA; and
- DLGSC.

The committee regularly receives recommendations from MRWA on funding priorities for bridges. MRWA inspects and evaluates the condition of local government bridges and has the expertise to assess priorities and make recommendations on remedial measures.

Implementation of updated Road Costs Used in the Asset Preservation Model

In 2023-24, the Commission applied updated road costs in its determination of road asset preservation need, following a review of the costs used in the APM with input from local governments. Accurate road costs underpin the reliability of the APM, which is used for allocating Commonwealth Financial Assistance local road grants and State Direct grants. The Commonwealth has also used the Commission's APM assessments as a basis for allocating a component of Roads to Recovery (R2R) funding and the Local Roads and Community Infrastructure Program.

The review of road costs was more fully reported in the 2019-20 Annual Report.
