There would be only One further Suggestion I would make,

In regards to proper & sustainable Breeding Practices, I would suggest that a MAXIMUM of 3 Litters from any one Female Dog throw-out its lifetime should be sufficient.

This is in line with the current protocols used by the Greyhound Industry. I would formalise it in Legislation

Additionally I see the practice of Breeding a Female Dog more than twice in an 18 month period to be Cruel & Unnecessary. I would extend this period out to 2 Years and at the same time make it an Offence Under Cruelty to an Animal to breed it more than twice within this period.

It would put an end to the manipulation of some dogs & hopefully dissuade some from undertaking this cruel & unnecessary practice.

It would also curtail the high incidence that occurs within Dogs West ranks & a practice that is not adequately policed due to the low & insignificant fines handed out.

If it was made a Cruelty issue then membership of such organisations would not be permitted & resulting in loss of any exemptions that might be granted.
