# **Transitioning Pet Shops to Adoption Centres**

2. Would you purchase a behaviour and health checked rescue dog from a pet shop?
Yes – this would be the only kind of dog I would be interested in purchasing.
What background information would you want on the rescue dog?
Any information on parents/breeding if it were available, temperament, any behavioural issues, any previous medical issues.
4. Do you think transitioning pet shops to adoption centres is beneficial?
Absolutely. Making it so easy to adopt a dog from a store or shelter rather than buying a farmed puppy from a pet store will drastically increase the rate dogs are adopted, in addition to decreasing the overload on shelters (and thus the euthanasia rates in said shelters).

# Mandatory dog de-sexing for non-breeding dogs

6. How do you feel about mandatory dog de-sexing for non-breeding dogs?
I feel this should have long since been made compulsory. There is absolutely no reason (except rare medically necessary cases) why any dog should retain its ability to have puppies unless the dog is going to be used for breeding with a registered breeder. There are too many accidental litters being sold on sites such as Gumtree or dumped when they cannot be sold.
7. Exemptions from mandatory de-sexing will apply for health and welfare reasons as assessed by a veterinarian, and if the dog owner is a registered breeder. Are there any other reasons why a dog should be exempt from being de-sexed?
No.
8. Should mandatory dog de-sexing apply to all dogs, including existing dogs, or just dogs born after a particular date?
I believe it should apply to all dogs although I understand there would be difficulties in implementing and enforcing this.

# **Centralised Registration System**

9. How will a centralised registration system benefit you?
I doubt such a system will benefit individual dog owners – it will, however, aid in stamping out those who haven't registered their dogs as they intend to use them for breeding purposes.

Yes, although this does depend on how much the government intends to increase them.

Absolutely. In my opinion, monitoring and enforcing the compliance of breeders with the new standards is absolutely imperative to the efficacy of the new system.

13. Are there any other benefits, costs and/or issues associated with breeder registration that are not captured in this table? Please detail.
Not to my knowledge.
14. Should there be any restrictions on who can register as a dog breeder? If so, what should these be?
At a bare minimum, no one with a previous investigation into or conviction for animal cruelty should be able to register as a dog breeder. I also believe that the premises they intend to use for breeding should be assessed and any person who wishes to breed dogs should not be allowed to do so if their premises and facilities are not up to standard.
15. Do you think local government is best placed to enforce dog breeder registration? Why, or why not?
Yes – as I believe enforcing this at a State or Federal level will allow people to slip through the cracks, so to speak. The government at these higher levels simply has too much on its plate to make these issues a priority. If these new standards are to be enforced effectively, it ought to be done at a local government level.

#### Please provide reasons:

There should be a defined number of breeding dogs, however this should be dictated by the capacity of the premises on which the breeder intends to house the dogs. Having a set limit may amount to cruelty in some cases. For example, it would not be reasonable to set a limit of 20 breeding dogs (taking into consideration the amount of puppies they may bear) when some breeders may only have the capacity for 10. These breeders would then be permitted by law to cram double the amount of dogs they actually have the room for into their facilities. There ought to be statutory limits set based on the size and capacity of the breeder's premises.
