



Public Interest Assessment

Under the *Liquor Control Act 1988* (LC Act), the Director of Liquor Licensing (DLL) has the discretion to grant or refuse any application if the DLL considers this to be in the public interest. The DLL requires certain applicants to fill in this Public Interest Assessment (PIA) form and provide supporting evidence that their application is in the public interest. If you are applying for the grant of any of the following licences, or the removal of one of these types of existing licence to another premises, you will need to complete a PIA to provide evidence that your application is in the public interest:

- hotel/hotel restricted
- tavern/tavern restricted
- liquor store
- nightclub.3

A PIA is also required if you are applying for an extended trading permit for extended hours, which has a duration of more than 3 weeks⁴, or for a temporary bar (refer to the Temporary bars policy). The DLL may also ask for a PIA to be prepared as part of any application under the LC Act, and will ask for one if it would assist in deciding whether the grant of the application is in the public interest.

The DLL will consider the following factors when determining whether granting the application is in the public interest, but this list is not exhaustive:

- the harm that might be caused due to the use of alcohol
- whether there might be a decrease in the amenity, quiet or good order of the locality
- whether people who live or work nearby might suffer offence, annoyance, disturbance or inconvenience
- how it might affect tourism, culture and the community.⁵

The level of detail required will be unique to each PIA. If you do not provide enough information, your application might not succeed or you might be asked to provide further information.

2.1 What is the proposed manner of trade and your target client base?

Bhutan Event House was established in 2022 as a community-based Reception/Function Center catering to the Bhutanese population in Perth. Currently, operating under a small bar license, we provide a welcoming space for cultural celebrations, social gatherings, and fundraising events. With the Bhutanese community in Western Australia now numbering an estimated 25,000 individuals, Bhutan Event House plays a vital role in preserving and promoting our rich cultural heritage.

A substantial portion of our events is catered towards Bhutanese community members culturally aligned with Bhutanese Standard Time and often require operations beyond the current 12 a.m. trading limit to accommodate countdowns and celebrations. Furthermore, in recent years, many Bhutanese artists have travelled to Australia to perform cultural shows; for Bhutanese living in Australia at large however, due to our limited trading hours, Bhutan Event House has been unable to fully host these performances.

Part 4 — Minimising the potential for alcohol to cause harm

Excessive consumption of alcohol can cause health problems, increase the risk of accidents and contribute to societal problems such as domestic violence. You must demonstrate how the responsible conduct of your business will minimise the potential for alcohol to cause harm. This could be through promoting a culture of responsible consumption of alcohol amongst staff and patrons, having strategies to prevent alcohol being served to juveniles, discouraging rapid or excessive consumption of alcohol, being alert for signs of intoxication and not serving drunk people.

4.1 What strategies will you use to minimise harm from the use of alcohol?

The management plan in accordance with the Liquor Control Act 1988 will prioritize compliance with all legal requirements and regulations related to the sale and service of alcohol. This includes adhering to responsible service of alcohol practices, ensuring staff are properly trained in alcohol service, monitoring customer intoxication levels, and preventing underage drinking. Additionally, the management plan will include

strategies for maintaining a safe and secure environment, addressing noise and disturbance issues, and managing crowd control effectively. By upholding the standards set forth in the Liquor Control Act 1988, BEH International Pty Ltd can operate responsibly and contribute to a safe and enjoyable drinking environment for patrons. We have a Harm Minimisation and Small Bar Management Plan in place in compliance with all legal requirements and regulations related to the sale and service of alcohol.

Part 5 — Impact on the amenity, quiet or good order of the locality

A well designed premises will make it easier to prevent negative impacts on the locality. For example if a premises is:

- in good repair, well lit, with operational CCTV and designed to allow passive surveillance of areas such as the car park and entrances, it will tend to discourage anti-social behaviours such as vandalism or crime
- designed with sufficient parking and with good transport options available, it will allow patrons to leave the area quickly rather than potentially inconveniencing the neighbours
- provided with sound insulation sufficient for the proposed entertainment, it will prevent the surrounds from being exposed to unacceptable noise.

5.1 How will your premises design protect the amenity, quiet or good order of the locality?

Installed Security systems (CCTV) outside and within the premises to protect the amenity, quiet or good order of the locality. The CCTV systems are continuously monitored and security alarm integrated to discourage anti-social behaviours such as vandalism or crime. While the business location is in a non-residential locality our priority is in minimizing noise disruptions and ensuring all events comply with local noise regulations. Adequate on-site parking available to prevent traffic congestion in the surrounding area as the business operation starts after 6PM on weekends, when all the other businesses are closed. A structured waste management plan is implemented to maintain cleanliness, with regular waste disposal and recycling practices in place. Outdoor lighting is designed to enhance security without causing unnecessary light pollution for nearby residents.

Part 6 — Impact on the people who live or work nearby, and whether they might suffer offence, annoyance, disturbance or inconvenience

You need to demonstrate how your business will be a responsible member of the community and minimise negative impacts on the people who live or work nearby. For example, this could include:

- keeping the premises and surrounds clean and tidy, monitoring patron behaviour and discouraging anti-social behaviour
- ensuring that any entertainment is in keeping with the locality, that those present are within the allowed accommodation numbers and licensed crowd controllers are used if required
- asking departing patrons to keep the noise down so they do not disturb the neighbourhood
- being responsive to any complaints from neighbours and working with them to resolve issues.

6.1 What actions will you take to minimise the impact on people who live or work nearby?

- keeping the premises and surrounds clean and tidy, monitoring patron behaviour and discouraging anti-social behaviour
 We have 2 professional cleaners working every Saturday and Sunday morning focussing on cleaning inside and outside the premises ensuring to maintain utmost cleanliness standards aligned with neighbours requirements.
 We have 2 commercial 1200L waste bottle and recyclable bins and 2 x 500L bins for other waste materials.
- ensuring that any entertainment is in keeping with the locality, that those
 present are within the allowed accommodation numbers and licensed crowd
 controllers are used if required
 We have 5 security personnel to maintain safety of our clients and to control
 crowd during organised events
- asking departing patrons to keep the noise down so they do not disturb the neighbourhood
 Departing patrons are offered with free drinking water and to requested to keep the noise down.
- being responsive to any complaints from neighbours and working with them to resolve issues.

All neighbourhood complains are resolved swiftly and cordially.

Bhutan Event House is in a semi-industrial area, where neighbouring businesses close by 5 PM. As our operations begin only after this time, there is no impact on the surrounding businesses or residents

Part 7 — Impact on tourism, culture and the community

When making licensing decisions under the LC Act, the DLL is required to consider the proper development of the liquor industry, the tourism industry and other hospitality industries in the State. This is your opportunity to expand on how the grant of your application would result in positive developments to tourism, culture and the community. The local community and Bhutanese population will greatly benefit from the grant of this application as it will promote tourism, by attracting Bhutanese music artists and movie / film artists to travel to Perth and Australia for cultural shows and filmmaking. Bhutan Event House has been a partner with Bhutanese movie and Music industry several movie projects and cultural shows.
